- Module Mounting structure: Aluminum rail or adhesive based structures
- DC Cables: Cu/PVC/XLPE EVA UV-resistant, single core multi- stranded flexible copper cables (rated for UV protection and confirming to IEC 60228 amended up to date.
- AC and DC combiner boxes Detail in the ITB

Eligible Nepali firms or international firms can submit their bids.
