Working as an integral member of project teams, the **Assistant Manager, Technical & Implementation** will be based out of Hanoi, Vietnam and be responsible for supporting the Technical & Implementation team in Singapore on projects in the South East Asia countries which InfraCo Asia is mandated to operate in. This includes supporting the T&I team in providing oversight and guidance in undertaking assessment, planning, documentation, design, tendering, contracting and construction of projects in development and construction stages, as well as monitoring performance and providing support to project companies for project in operational stage where relevant.

Key responsibilities include (i) ensuring all related project risk management, procurement, planning, design, specification, tendering, contracting and contract management activities are executed on time and in accordance with international standards for quality, environmental protection, social impact, and health and safety and (ii) documentation and specification of requirements for compliance by consultants and





works contractors with the IFC Performance Standards on Environmental and Social Sustainability, including with respect to occupational health and safety.

This role reports into the Head, Technical and Implementation in Singapore and will have a matrix reporting line to the Regional Manager, South East Asia based out of Hanoi, Vietnam.

Requirements and Attributes

- Bachelor's degree in Engineering from a reputable university; Master's degree in similar or related disciplines would be advantageous;
